PRIVACY POLICY FOR ZENKA FINANCE LIMITED WEBSITE

I. USE OF INFORMATION

- 1. If you choose to give us feedback on the website via the application form or if you request additional information from Zenka, you will be asked for your name and address and will have the option of providing other information, such as your profession, the information collected will be used consistency with this Policy.
- 2. The information collected will be used to improve our services, can be used by advising you about our products, services and other opportunities, maintaining your account with us.

II. INFORMATION WE COLLECT AND STORE

- 1. We collect your personal data when you provide them to us directly, use our products, services or website, use cookies or similar technology, and when we receive personal data from third parties.
- 2. Please be informed that we use a tool that allows us to make automatic decisions. Making decisions in an exclusively automated way is the ability to make decisions using technological tools without human involvement. We use the above technology to reduce the risk of making a mistake, lowering the risk of non-payment of a loan, and most importantly, it allows a credit decision to be made in a shorter period of time.
- 3. We would like to kindly inform you that we collect your data on few ways:
 - a. Automatically when you visit our website. Please take into account that these kind of data are mostly collected by cookie files and tracking of navigation signals;
 - b. Your personal data can be provided through third party for example via credit bureau and from our business partners;
 - c. We can obtain your data directly from you, a specially for these that you left on our application from, on our website, via social medias, during phone calls, presented on

- 2. We can transfer your personal data to other companies which are part of the Zenka's capital group for internal administrative purposes.
- 3. Please be informed that we can provide your information to selected third parties in connection with the fulfillment of our contractual obligations to you and for other purposes described in this Policy. Below you will find the list of services providers to which we may entrust your personal data. The services provider may provide the following services:
